



**UMSHWATHI LOCAL MUNICIPALITY**

**INDIGENT REGISTRATION AND PENSIONERS REBATE: FINANCIAL YEAR 2025/2026**

In terms of Section 74 of the Local Government Municipal Systems Act, act No. 32 of 2000 read together with the Indigent Policy of uMshwathi Municipality notice is hereby given that uMshwathi Municipality calls for residents, who qualify, to register as an Indigent for the 2025/2026 Financial Year.

**INDIGENT SUPPORT APPLICATION CRITERIA**

**Residents must meet the following criteria in order to apply for Indigent Support:**

1. The combined household income must be Five thousand Three Hundred and Eighty rand's and below
2. **Applicant must be a member of a domestic household who is responsible for the payment of the services and is receiving services from uMshwathi Municipality**
3. The applicant will only qualify for Indigent Support for one (1) property in circumstances where more than one (1) property is owned
4. The applicant must reside permanently on the property

**Applicants are to take note of the following IMPORTANT information;**

- Each application will be evaluated and verified thereafter
- Only fully completed applications accompanied by the required documentation will be assessed, the onus is therefor upon the applicant to ensure compliance to the application process
- Applicants are requested to note that the verification includes company registrations and applicants are urged to note points 11 and 12 above (documents required)
- Any false information supplied will be seen as a criminal offense and Council reserves the right to take action, including legal action, against anyone supplying false or incorrect information
- The Municipality shall at any time during the registration process send a duly authorised agent to the premises of the applicant applying for indigent to conduct an on-site audit of information received on the Indigent application form.
- All previous applicants are requested to re-apply annually
- All applications will be vetted by a duly appointed service provider and process through various databases to verify income, directorship, businesses, properties owned and any other information supplied.
- Note the submission of the completed application form provides the Municipality with the confirmation to vet the specifics (information) as contained within the application through third parties.

**10 March 2025 until 31 May 2025**




